This program relies upon WHF members who volunteer their time and expertise to teach small group sessions about basic financial literacy topics to low-income women and other at-risk individuals. The PFC Program is one way that the Foundation works in partnership with local community-based organizations.

◆ **The Partnership Grant Program**

The Foundation awards financial grants to non-profit organizations in the Washington, DC area carrying out activities that are consistent with the Foundation's mission and with whom the Foundation can form long-term service partnerships. The funds come from member donations and corporate sponsors. The Foundation conducts an annual wine tasting and a golf tournament to raise corporate funds.
